

ORDINANCE 2019 - 270

ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE FISCAL
YEAR BEGINNING THE 1ST DAY OF JULY, 2019 AND ENDING
THE 30TH DAY OF JUNE 2020

WHEREAS, The Board of Library Trustees of the Frankfort Public Library District, of the Counties of Cook and Will, State of Illinois, has prepared or caused to be prepared a tentative form of the Annual Budget and Appropriation for said Public Library District for the fiscal year beginning July 1, 2019 and ending June 30, 2020 and the same has been conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

WHEREAS, a public hearing was held as to such Annual Budget and Appropriation Ordinance on August 29, 2019, notice of which was given at least thirty (30) days prior thereto by publishing notice thereof in a newspaper of general circulation in the Frankfort Public Library District; and

WHEREAS, all other legal requirements have been duly complied with by the Board of Library Trustees of the Frankfort Public Library District;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF LIBRARY TRUSTEES OF THE FRANKFORT PUBLIC LIBRARY DISTRICT, IN THE COUNTIES OF COOK AND WILL, STATE OF ILLINOIS, AS FOLLOWS:


CERTIFICATE
