- B. Strategic Plan Quarterly Review

The Committee also discussed the myriad of ways the Library partnered with other organizations this quarter to provide all sorts of returning and new services. Community partnerships continues to be an area of strength for the Library.
  - 2. The Committee discussed progress in the area of Space, including a large HVAC project, material organization changes, and sustainable-friendly landscaping.

- 3. The Committee discussed changes to Library collections to meet the needs of the community, including expanding the Library of Things and expanding the Museum Adventure Pass.
- 4. Areas of growth related to communication included the Outreach Vehicle Fundraiser, a new comment box system, and LibraryAware, a new tool for making accessible booklists.
- 5. The Committee discussed Up Next Items, which include work on the staff culture statement, participation in a Chamber of Commerce competition, and planning the Library's 60<sup>th</sup> Birthday. Additionally, staff would like to prioritize finding opportunities to collaborate program scheduling across departments to reach wider audiences, and a focus on more outreach to the high school district.
- 6. The Quarterly Report now includes connections to the new Illinois Public Library State Standards, to show how the work being done at the Library fits into the framework of librarianship across the state.
