- Fund balances—Net asset goal for FY18–19 is \$100,000. Director Gregoire will update in April 2019.

Motion made by Trustee Skibinski to approve the bills for January 2019 as presented. Seconded by Trustee Look. Question made regarding cost of consistent plumbing repairs in east end restrooms versus toilet replacement estimate of \$5,600. All trustees voted "Aye." Motion carried.

X. UNFINISHED BUSINESS

 Working budget process—Adult Books budget is \$61,000. Estimated Special Reserve Fund contribution for FY 19–20 is \$50,000, with an estimated budget of \$29,250 for repairs in 2020 and total goal balance of \$125,000 of end of fiscal year. Net income expected \$35,144.53. Personnel costs expected to rise due to minimum wage increase.

Building loan rate to increase December 2020. Trustees discussed the benefits of a foundation versus a referendum. Trustees Look and Skibinski suggested advertising the impact of the library's financial situation on library resources.

XI. NEW BUSINESS

 Decrease Adult Books working budget by \$8,800 and increase Building Maintenance by \$8,800, reflecting additional funds for Adult Books from the Friends.

Motion made by Trustee Skibinski to change working budget for FY 2018-2019 Adult Books to \$55,200 and Building Maintenance to \$78,800. Seconded by Trustee Leyva. Reallocating \$8,800 from the Adult Books budget to Building Maintenance for new cleaning services. \$8,800 donated by Friends for Adult Books. All trustees voted "Aye." Motion carried.
