

**A RESOLUTION ADOPTING THE PREVAILING WAGE RATES FOR LABORERS,
WORKERS & MECHANICS EMPLOYED ON PUBLIC WORKS OF
FRANKFORT PUBLIC LIBRARY DISTRICT,
COOK AND WILL COUNTIES, ILLINOIS**

WHEREAS, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workmen employed in any public works by the State, county, city or any public body or political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, being Chapter 820, ILCS, Act 130; and

WHEREAS, the aforesaid Act requires that the Board of Library Trustees of the Frankfort Public Library District investigate and ascertain the prevailing rate of wages as defined in said act for laborers, mechanics and other workers in the locality of said Library District employed in performing construction of public works for said Library District.

NOW, THEREFORE, Be It Resolved by the Board of Library Trustees of the Frankfort Public Library District, Cook and Will Counties, Illinois, as follows:

- **Section 1:** To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Library District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Will County as determined by the Department of Labor of the State of Illinois as of June, 2017, If the Department adopts different rates after July 1, 2017 during the month of July, 2016, a copy of that determination will be appended hereto and incorporated herein by reference when it is available from the Department. As required by said Act, any and all revisions of the prevailing rate of wages by the Department shall supersede the Department's June determination and apply to any and all public works construction undertaken by the

Library. The definition of terms appearing in this Resolution which are used in aforesaid Act shall be the same as in said Act.

- **Section 2:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any or employment except public works construction of this Library District to the extent required by the aforesaid Act.
- **Section 3:** The Secretary of the Board of Library Trustees shall publicly post or keep available for inspection by any interested party in the main office of this Library District this determination of such prevailing rate of wage.
- **Section 4:** The Secretary of the Board of Library Trustees shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workmen whose wages will be affected by such rates.
- **Section 5:** The Secretary of the Board of Library Trustees shall promptly file a certificate copy of this Resolution with both the Secretary of State and the Department of Labor of the State of Illinois.
- **Section 6:** Within thirty (30) days after the filing of a certified copy of this Resolution with the Secretary of State, the Secretary of the Board of Library Trustees shall cause to be published in a newspaper of general circulation within the area a Notice of Determination and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
- **Section 7:** This Resolution shall be in full force and effect upon its passage and approval as required by law.
